Our mission is to fill the void in state government coverage caused by the decline of traditional journalism organizations and to improve California's democracy by increasing government transparency, holding politicians accountable, and empowering Californians to participate meaningfully in their own governance. We do that by informing and engaging Californians about state government and public policy that affects their lives, with a focus on education, environment, economy, health and the
