



Dear Sir/Madam,

I am writing to bring to your attention some concerns I have regarding the compensation and earnings structure for Uber Eats drivers. I have been driving for Uber Eats since 2022, and initially, it seemed like a good means of extra income. However, since the middle of 2023, it appears that Uber's base pay has decreased significantly.

On average, Uber is paying its drivers anywhere between \$3-4 per order, sometimes even less, regardless of the distance the order is going or the number of items the customer has purchased. Additionally, I have noticed that the mileage calculation provided by the Uber Eats app is hardly ever accurate. When I input the delivery addresses into Google Maps, the actual distance tends to be more than what is stated on the Uber Eats app.

Furthermore, the earnings from Proposition 22 (Prop 22) do not seem to be properly calculated. According to the Uber Eats app, Prop 22 earnings are supposed to be calculated as follows: (120% x minimum wage in your city x number of total active hours) + (0.34 x total number of miles driven). However, after a recent conversation with one of Uber's representatives, I was informed that the Prop 22 earnings are based solely on the total number of active hours multiplied by \$0.30 per mile. This contradicts the information provided in the app, indicating that Uber Eats drivers are not being compensated properly.

I believe that these issues are not only affecting me but also other Uber Eats drivers who rely on this income. I am reaching out to the Department of Industrial Relations in the hope that these concerns can be addressed and resolved in a fair and just manner.

I would appreciate the opportunity to discuss these matters further and provide any additional information that may be required. Thank you for your attention to this matter, and I look forward to your prompt response.
